## Summary

A loss of \$9,760.87 was realised in the 2015/16 period against a forecasted profit of \$846.00.

As of 30th June 2016, the RBMS had \$11,013.41 in net assets (all cash in the bank).

- \$4,712.71 in the RBMS term deposit
- \$6,300.70 in the RBMS cheque account

This compares against the \$20,774.28 in net assets (all cash in the bank) as at June 30th 2015.

The loss in FY2015/16 was largely a result of the large deposit (\$17,583.00) paid to secure the venue for the 8ASM conference in this financial year. The success of the 2nd Awards Night, which realised a profit of \$8,418.95, meant that the RBMS was in a position to cover this deposit.

The 8ASM conference was a success and the refund has now been returned. The unspent funds from the conference are currently being resolved, but are likely to total about \$60,000.

The profit from the awards night and 8ASM was far greater than expected and in large part reflects the large amount of work completed by volunteers. It means that the RBMS is in a very healthy financial position for FY 16/17 but is unlikely to represent a sustainable revenue stream into the future.
